

## **AFFIDAVIT**

I,Dilraj Singh Son of Sh. Jai Singh, Age 56, Chairman of the Galaxy Educational Trust Thanesar Distt. Kurukshetra Running the Galaxy Public School VPO Bhaini Kalan Distt. Karnal, do hereby solemnly affirm and sincerely stateas follows:

- 1. That Galaxy Educational Trust Thanesar Distt. Kurukshetra is a registered Trust under the trust Act.
- 2. That the Galaxy Educational Trust Thanesar Distt. Kurukshetra is of Non-Proprietary Character.
- 3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the Institution is being and will be diverted to anyindividual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and nonrecurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That school is not paying any charges towards using name, motto, logo or anyother non-academic activities to any other institution, organization or body.
- 6. That the school will not open classes under CBSE pattern particularly classIX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individuallygone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes toabide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESIand Labour Laws etc. with respect to the school and staff of the school.
- 9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concernedmunicipal or state authorities from time to time as per the prescribed term.
- 10. That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per theprovisions contained in affiliation bye-laws are available with the school before starting classes.
- 12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee
- 13. That the school will not coerce any student/parent to buy books/stationary/uniformfrom any particular shop.
- 14. That the school shall strive to make efforts for conservation of environment.
- 15. That the school will ensure that the school fulfills all essential requirement beforeapplying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.

That the school will not start CBSE pattern classes without submitting acommencement certificate to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation by elaws along with general rules.

17. That State pattern classes IX to XII running prior to the affiliation to CBSE wouldbe sponsored for the State Board Examination. State Pattern classes IX to XII will be closed in a phased manner. No admission will be taken in the State Board Pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.


